7. Documentary evidence in supported to teaching experience mentioned in the application form.
8. Documentary evidence in Awards mentioned in the application form.
9. Documentary evidence of the period of active service spent for pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave.
