The quotation shall be opened on the same day i.e. 29/09/2023 at 03:00 PM. The bidders may attend the said meeting on 29/09/2023.

Terms and Conditions:

1. The work will be carried out as per the satisfaction of the engineer in charge.
2. The agency/firm must deposit EMD of Rs. 10,000/- (Rupees Ten thousand only) in the form of NEFT/RTGS in favour of Central University of Haryana's Account No. 7824000100000392 IFSC Code: PUNB0782400 (Punjab National Bank, Jant-Pali, Mahendergarh).

3. The agency must submit the details of EMD submitted along with quotation i.e. UTR details etc. along with bank account details of the agency/firm for the purpose of release of EMD of unsuccessful bidders.
4. GST registration certificate of the agency is required to be enclosed along with quotation.
5. Copy of PAN Card is required to be enclosed along with quotation.
6. Copy of Experience Certificate of similar nature of work from any Govt. Institution/Departments is required to be enclosed along with quotation.
7. Validity of the quotations will be 30 days from the date of opening.
8. The rate includes all taxes like GST, and other taxes and carriage of the material etc.
9. Time of completion of work will be 30 days.
10. No advance payment will be made.
11. Conditional quotations will not be considered.
12. The agency should inspect the site before quoting the rate.
13. The quantity of items in BOQ is tentative which may change depending upon site conditions.
14. The CUH will not be responsible for any accident. The agency should provide proper safety tools to its workers.
15. Time is the main essence of the contract. Hence, an appropriate penalty maximum upto 10% can be imposed on the agency for delayed completion of work.
16. No labor below the age of 18 years be employed on site.
17. All T&P required will be arranged by the contractor.
18. The agency/Contractor shall make its own arrangement of water & electricity.
19. Security deposit @5% shall be recovered from the bill of the bidder and security will be released after one year from the actual date of completion of work i.e. after the expiry of maintenance period.
20. The Defect Liability period will be one year from the actual date of completion.
