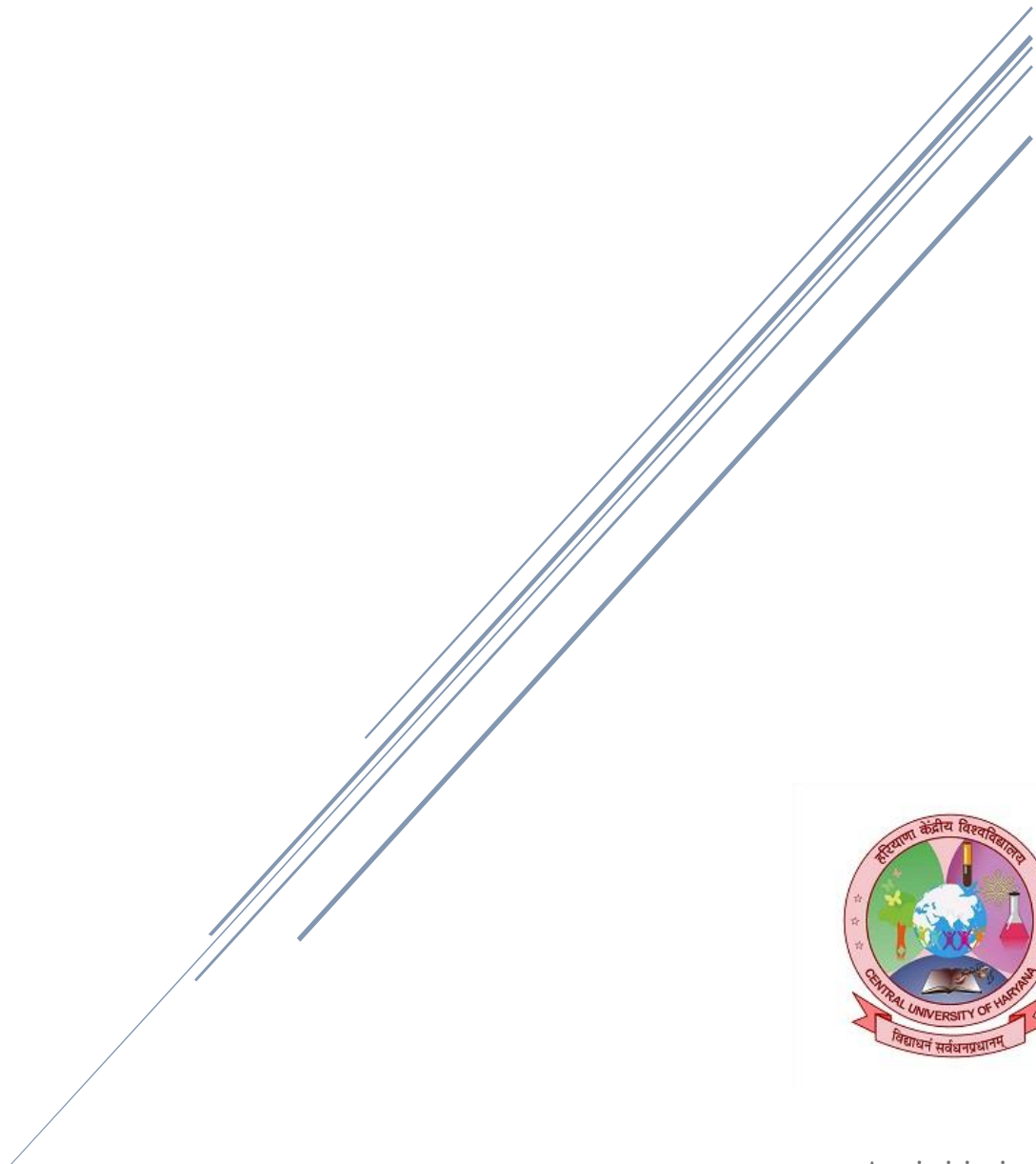

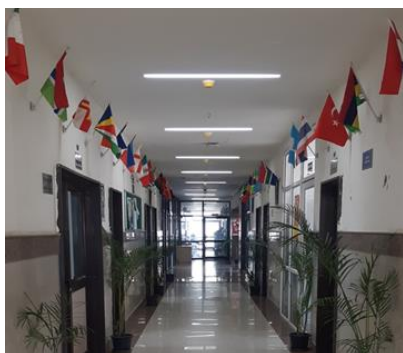
| Central University of Haryana

| Syllabus

I. Theory

RPE 01: Philosophy and Ethics (3 hours)

1. Introduction to philosophy: definition, nature and scope, concept, branches
2. Ethics: definition, moral philosophy, nature of moral judgements and reactions

RPE 02: Scientific Conduct (5 hours)

1. Ethics with respect to science and research
2. Intellectual honesty and research integrity
3. Scientific misconducts: Falsification, Fabrication, and Plagiarism (FFP)
4. Redundant publications: duplicate and overlapping publications, salami slicing
5. Selective reporting and misrepresentation of data

RPE 03: Publication Ethics (7 hours)

1. Publication ethics: definition, introduction and importance
2. Best practices / standards setting initiatives and guidelines: COPE, WAME, etc.
3. Conflicts of interest
4. Publication misconduct: definition, concept, problems that lead to unethical behaviour and vice versa, types
5. Violation of publication ethics, authorship and contributorship
6. Identification of publication misconduct, complaints and appeals
7. Predatory publishers and journals

II. Practice

RPE 04: Open Access Publishing (4 hours)

1. Open access publications and initiatives
2. SHERPA/RoMEO online resource to check publisher copyright & self-archiving policies
3. Software tool to identify predatory publications developed by SPPU
4. Journal finder / journal suggestion tools viz. JANE, Elsevier Journal Finder, Springer Journal Suggested, etc.

RPE 05: Publication Misconduct (4 hours)

A. Group Discussions (2 hours)

1. Subject specific ethical issues, FFP, authorship
2. Conflicts of interest
3. Complaints and appeals: examples and fraud from India and abroad

B. Software Tools (2 hours)

1. Use of plagiarism software like Turnitin, Urkund and other open source software tools

RPE 06: Databases and Research Metrics (7 hours)

A. Databases (4 hours)

1. Indexing databases
2. Citation databases: Web of Science, Scopus, etc.

B. Research Metrics (3 hours)

1. Impact Factor of journal as per Journal Citation Report, SNIP, SIR, IPP, Cite Score
2. Metrics: h-index, g index, i10 index, altmetrics

| Pedagogy

- Online teaching
- Discussions on a common platform
- Live online lectures with practical demonstrations
- e-Content prepared/published by experts, suggested study materials and recordings of the lectures are shared
- Clearing doubts on a common discussion forum

| Examination/ Evaluation

- Continuous assessment through tutorials, assignments, quizzes, and group discussions. Weightage for active participation
- Internal: 40 marks; Theory examination: 60 marks (at the end of the Course)
- Examination as per the format/mode adopted by the University
- Two credits are awarded to students upon successful completion of the Course

| Learning outcome

- By the end of the Course, students will be able to understand the importance of being ethical in carrying out research and publication activities. They will be able to differentiate the quality publication practices and how to be cognisant about dubious publishing practices/publishers. More importantly, there will be an increased awareness about 'open access' and contribution of research output to open access publishing platforms. The learners will also get acquainted with the software/databases which are necessary for carrying out research work.
