Those who unable to reach Academic Block-I will take the pledge under the leadership of their respective HODs and Deans, and <u>send the photographs of the same</u> to the office of <u>Chief</u> <u>Vigilance Officer (cvo@cuh.ac.in)</u> latest by <u>05:00 PM on 31/10/2022</u>. These photographs along with the report will be submitted immediately thereafter to the Central Vigilance Commission.

The teaching staff who have a class at 11:00 AM are required to administer the pledge in their respective classes and ensure clear photographs of the event. This pledge needs to be circulated among the stakeholders over social media for wider publicity.

**Walkathon:** A walkathon would be organized in the campus for greater visibility and mass appeal on 3<sup>rd</sup> Nov 2022 at 10.45am.
