1. The intending bidder must read the terms and condition carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the document required.

- But the bid can only be submitted online after uploading the mandatory scanned documents of original payment instrument of NEFT/RTGS and other documents as specified in Annexure-I.
- 5. Those contractors not registered on the website mentioned above, are required to get registered beforehand.
- The intending bidder must have valid class-II or class-III digital signature with signing certificate to submit the bid.
- On opening date, the contractor can login and see the bid opening process. After opening of bids he will
 receive the competitor bid sheet.
- 8. Contractor can upload document in the form of JPG format and PDF format
- 9. Certificate of Financial Turnover: At the time of submission of bid, contractor may upload Affidavit/Certificate from CA mentioning Financial Turnover of last three years or for the period specified in the bid document and

further details if required may be asked from the contractor after opening of the technical bid. There is no need to upload entire voluminous balance sheet.

10. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue. In case of item rate tender and quotation % above or below in case of percentage rate tender.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".

Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

- 11. The technical bid shall be opened online first on due date and time as mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bed shall be communicated to them at a later date.
- 12. Tender documents may downloaded from Central Public Procurement Portal Website (https://eprocure.gov.in/eprocure/app) free of cost.
