Subject: Regarding API for Non-onboarded NSP States to perform One Time Registration (OTR) and Biometric Authentication (Bio-auth) of the applicants.

Sir/Madam,

I am directed to refer Government of India letter No. K-11017/2/2022-SCD-V, dated 23.09.2024 on the subject cited above and to say that the as per instructions issued by GOI, for implementation of Post Matric Scholarship Schemes for SCs, biometric based authentication (bio-auth) of all the eligible applicants is mandatory for the disbursement of Central share payment under the Post-Matric and Pre-Matric SC Scholarship schemes from AY 2024-25 onwards.

3. In this regard, National Scholarship Portal has earlier developed functionality for OTR (One Time Registration) and bio-auth on NSP portal for such States/UTs which are onboarded on NSP portal. It is informed that OTR facility also has the provision for bio-auth of students. Through this functionality, the bio-auth can be done by using the active mobile device.

4. Additionally, as per the directions of DBT Mission, NSP has now developed an API to facilitate the OTR and bio-auth for such States which are not on-boarded on NSP. The States, willing to use this facility, are required to integrate the API with the respective State scholarship portal. The detailed process of integration of API will be shared shortly by Government of India.

5. As Haryana State is not on-boarded on NSP and thus willing to opt for the OTR (One Time Registration) facility developed by NSP, so you are requested to integrate the OTR API developed by NSP with State Scholarship portal i.e. Harchhatravratti Portal to facilitate the OTR and Bio-Matric based authentication of all eligible applicants, immediately.

Respected Sir/Madam,

With reference to the letter dated 08th July 2024, regarding Instructions to the States/UTs for the implementation of Pre-Matric and Post Matric Scholarship Schemes for SCs, it is reiterated that biometric based authentication (bio-auth) of all the eligible applicants is mandatory for the disbursement of Central share payment under the Post-Matric and Pre-Matric SC Scholarship schemes from AY 2024-25 onwards.

2. In this regard, National Scholarship Portal has earlier developed a functionality for OTR (One Time Registration) and bio-auth on NSP portal for such State/UTs which are on-boarded on NSP portal. It is informed that OTR facility also has the provision for bio-auth of students. Through this functionality, the bio-auth can be done by using the active mobile device.

3. Additionally, as per the directions of DBT Mission, **NSP** has now developed an **API** to facilitate the OTR and bio-auth for such States which are not on-boarded on NSP. The States, willing to use this facility, are required to integrate the API with the respective State scholarship portals. The detailed process of integration of API will be shared shortly.

4. It is requested that the States which are not on-boarded on NSP and are willing to opt for the (One Time Registration) OTR facility developed by NSP may integrate the OTR API developed by NSP with their respective State scholarship portals. Hand Holding support for the States shall be arranged by the department and NSP.
