The Vice-Chancellor apprised the members that a Letter Patent Appeal (LPA) has already been filed by the University against the decision dated 07-09-2022 in above said CWP. The hearing of the LPA filed by the University is fixed on 19-01-2023 (Annexure-IV, Page-19).

The Council members suggested that the petitioner be appointed on the post of Driver against any equivalent vacant post in the University, to meets the Court orders after taking legal opinion. The appointment of the petitioner shall be subject to the final outcome of the LPA-957-2022 (O&M). The appointment shall be duly vetted by the Legal Expert before issuance.

Subject: Violation of UGC Reservation Policy in House Allotment Rules-2022 (SC 15% & ST 7.5%) by the Central University of Haryana.

Dear Sir,

Refers to the *Rules for Allotment of Residences in the Central University of Harayana-2022* (Annexure A) circulated via email on 28th October 2022 from the Estate and General Branch. We thoroughly went through the allotment rules and disagreed on the following points.

- 1. Refer 8.5 of Rules for Allotment of Residences in the Central University of Harayana-2022 says that: Reservation—for Staff quarters for Schedules Castes (SC)/ Scheduled Tribes (ST) Employees: 10% in Category 1 and 11 category and 5% in category 111 of staff quarters is reserved for SC/ST employees subject to their eligibility for allotment in the entitled types and in their turn from the separate waiting list to be maintained for the purpose. Vacancies available in the quota reserved for them would be allotted in the ratio of 2:1 to the SC and ST employees respectively. If there is no SC employee, the quota reserved for SC would be allotted to ST employees. This rule for allotment of houses to SC/ST staff in the Central University of Haryana clearly violates UGC letters rules for strict implementation of reservations to SC/ST staffs addressed to Registrars of all Central /State Universities
 - i) Letter No.F.1-5/2006 (SCT) dated 25th Aug 2006 (Annexure B),
 - ii) Letter No. F.1-5/2006(SCT) dated 5th March 2018 (Annexure C).
 - iii) Letter No. F.1-8/2014(SCT) dated 01-Feb 2021 (Annexure D).
- 2. On page 5, point 12, and Page 2 point 7(a) of UGC letter No.F.1-5/2006 (SCT) dated 25th August 2006 clearly mentioned that the percentage of reservation for staff quarters as 15% for SC and 7.5% for ST reservation in all types of houses. Even, CUH has also adopted this reservation policy in the previous house allotment rule (8.7 point) (Annexure E), but surprisingly, CUH has sharply reduced the reservation percentage which is a clear-cut violation of the reservation policy of the Govt. in the allotment of staff houses as mentioned in Letter No.F.1-5/2006 (SCT) dated 25th Aug 2006 (Annexure B).

The SC/ST cell along with SC/ST employees strongly condemn the Rules for Allotment of Residences in the Central University of Harayana-2022 which violate the UGC guidelines circulated time to time vide Letter No. 1-5/2006(SCT) dated 25 August 2006, UGC Letter F. 1-3/2008 (SCT) dated 30 September 2010, F. 1-5/2006 (SCT) dated 20 April 2018. The referred UGC letters strictly mention the implementation of reservation for SC/ST in the allotment of staff quarters as 15% for SC and 7.5% for ST respectively.

- 3. The present policy document (Allotment of Residences in the Central University of Harayana-22 (Annexure A) is an intentional act of direct contravention in SC/ST reservation in house allotment which shows the discriminatory intention and humiliation of the SC/ST community of the Central University of
- 4. Further, there should not be any restrictions/ limitations on the allotment of houses to SC/ST staff in any category of residence (Type 1-V). So, the reservation policy of UGC should be implemented in toto in all categories of residences in true spirit (15% for SC and 7.5% for ST).

Further, the Cell submits that Clause 8.7 (i) Reservation for Schedule Castes (SC)/ Schedule Tribes (ST) of the above referred 'Rules of Allotment of Residences' provides for reservation in allotment of quarters as under:

(i) The percentage of reservation in Type-1 to Type-IV quarters for SC/ST category employees shall be:
(a) SC- 15%
(b) ST- 7.5%

Sir, these 'Rules of Allotment of Residences' were notified in the year of 2018. At that time the university had only three kinds of residences (1) Type II, (2) Type IV and (3) Semi-permanent Residential Structures. Now the university has constructed two more types of quarters namely Type III and Type V.

The existing 'Rules of Allotment of Residences' don't provide for Reservation for Schedule Castes (SC)/ Schedule Tribes (ST) in Type Five and Semi-Permanent Residential Structures.

Hence, the Cell request your goodself to make appropriate changes in the existing 'Rules of Allotment of Residences' to provide 15% reservation for SC and 7.5 % reservation for ST categories in all types of residential quarters from Type-I to Type-V including Semi-Permanent Residential Structures.

Under the instructions and on behalf of my client Sh. Gaurav Kumar Driver aged about 36 years son of Sh. Vinay Kumar O/O Registrar, Central University of Haryana, Jant-Pali Distt. Mahendergarh and permanent resident of village & PO Pali, Tehsil & Distt. Mahendergarh, Haryana

I, hereby serve upon you with the following advance notice: -

1. That in the month of August, 2013 with the last date of 30.09.2013 university through circulation in different newspapers and website of the University advertised to fill up in non teaching position on regular basis different posts of different category including three unreserved posts of Driver. Petitioner on being eligible and qualified for the post of Driver in unreserved category applied well in time with all requisite documents and proper application fee. It is necessary to mention here that petitioner is 10+2 pass, has valid driving licence and is having 5 years and 2 months

as Driver as well as have knowledge of vehicle operation and ability to rectify minor defects in the vehicle.

- 2. That on 24.12.2013 about 22 candidates appeared before the selection committee for Trade Test and interview. Petitioner also on being eligible and qualified for the post of driver appeared for Trade Test and interview before the selection Committee out of which twelve candidates including the petitioner qualified the First round of Trade Test (driving on 8–shaped path). A comparative merit list on 25.12.2013 was prepared by the selection committee and it was forwarded to competent authority to issue appointment letters by appointing authority. Petitioner stood third in the selection list but he was not offered appointment letter.
- 3. That aggrieved against this my client filed CWP No. 25920 of 2017 before Hon'ble Pb and Haryana High court claiming writ in the nature of Mandamus directing the respondents to treat the initial appointment of the petitioner for the post of Driver on regular basis equal to the driver selected vide selection list dated 25.12.2013 (Annexure P-2) and writ of certiorari to quash the Selection List dated 06.10.2017 (Annexure P-7) and subsequent appointment of respondents No. 3 and 4 and impugned order dated 02.11.2017 (Annexure P-6) with all the consequential benefits appurtenant thereto alongwith the interest on the arrears at the rate of 12 % per annum, in the interest of justice.
- 4. That Hon'ble High court vide order dated 07.09.2022 allowed the writ petition with the following directions:

" Consequently the petition is allowed. The appointment of the petitioner would be treated as on regular basis w.e.f the date the other two selected candidates had been appointed in pursuance of advertisement issued in 2013. He would be entitled to the notional benefits. Accordingly, he would be paid the salary in the regular pay scale henceforth.

07.09.2022 Sd/ (Anupinder Singh Grewal) Judge" 5. That the order was passed in your presence after considering your written statement. My client submitted application along with certified copy of order to your office vide diary No. 2411 dated 16.08.2022 to implement the aforesaid order in letter and spirit.

6. That my client requested your office to do needful in compliance of order passed by Hon'ble high court and it is being delayed without any good reasons which is wrong and illegal. You are duty bound to comply with the order in letter and spirit without any delay

7. That your action is willful and intentional disobedience and violation of above High court order. My client made application to you grant the necessary relief which has not been granted to my client yet.

You are, therefore, requested through this notice to comply with the directions issued by Hon'ble High court and allow regular appointment for the post of driver earliest within 15 days from today. Otherwise my client shall be constrained to initiate contempt of court proceeding against you and in that event all the consequences and expenses shall be borne by you. It may be noted, please.

This application is for placing on record the affidavit dated 02.09.2022 of the Registrar of Central University, Haryana.

Application is allowed and affidavit dated 02.09.2022 is taken on

record subject to all just exceptions.

MAIN CASE

The petitioner has sought a direction to the respondents to treat the petitioner as driver appointed on regular basis in pursuance to the selection carried out in the year 2013.

Learned counsel for the petitioner submits that the petitioner had applied for the post of Driver in pursuance to the advertisement issued by the respondents in 2013. Three posts had been advertised but two persons had been selected. The marks obtained by the two selected candidates were 85 and 80 out of 100 marks. The petitioner had secured 75 marks but the selection

committee had not recommended the name of the petitioner for appointment without assigning any reasons. There were total 12 numbers of candidates and the petitioner was at number 3. The petitioner has obtained maximum 50 out of 60 marks in the trade test which was also the score obtained by two other selected candidates who had been recommended for appointment. The petitioner had been representing to the respondents and he had been assured that he would be accommodated but instead of appointing the petitioner on regular basis he had been appointed on contract basis in the year 2014. His services were terminated in the year 2017 but he was re-engaged on outsourcing on 14.12.2021. He also submits that the respondents had carried out selection in the year 2016 but as the petitioner was overage he could not participate in that selection.

Learned counsel for the respondents, however, submits that the selection committee had recommended only two candidates for appointment and the petitioner was not recommended by the selection committee although he did secure 75 marks and was at number 3 in the merit list. The petitioner did not challenge the selection at any time earlier. In the meantime, the respondents had carried out fresh selection in the year 2016 wherein the petitioner did not participate. He also states that there is a delay in preferring this petition. In support of his submission he has relied upon the judgment of the Supreme Court in the case of M.V. Thimmaiah and others Vs. Union **Public Service Commission and others**, reported as 2008 (2) SCC 119. He also submits that in response to the order passed by this Court

on 13.07.2022, an affidavit has been filed by respondent No.2 wherein it is stated that there is no vacant post of driver against which the petitioner could be adjusted.

Heard.

The petitioner had applied for the post of Driver in pursuance to the advertisement issued by the respondents on 30.09.2013. 12 candidates are stated to have been called for the trade test. The selection committee had recommended only two candidates who had secured 85 and 80 marks for appointment. The petitioner had secured 75 out of 100 marks and was at serial No.3 in the merit list. The advertisement was issued for three posts. The selection committee has not assigned any reasons whatsoever as to how the petitioner was not found suitable for recommendation especially when he has secured 75 marks out of 100 marks including 50 marks out of 60 marks in the trade test. The petitioner had been re-appointed on contractual basis in the year 2014 and thereafter his services had been terminated. He has again been adjusted through outsourcing meaning thereby that the work for the post of Driver did exist especially in the year 2013 when the advertisement had been issued. The petitioner has received unfair treatment at the hands of the respondents inasmuch as his case was not recommended for appointment although he was number 3 in the merit list. He had become overage in the year 2016 when the fresh selection was made by the respondents. Respondents have stated that there is no vacant post of driver but the fact remains that the petitioner is still working with the respondents on outsourcing basis. The judgment of the Supreme Court in the case of M.V. Thimmaiah and others Vs. Union Public Service Commission and others (supra) relied upon by the

learned counsel for the respondent is distinguishable on facts and not applicable to the instant case. In that case, allegations of mala fide had been levelled against the chairman of the selection committee but the same were unsubstantiated. It was in such circumstances that the court had held that the selection cannot be set aside and that recommendation of the selection committee cannot be challenged except on the ground of mala fide or serious violation of the statutory rules and the Courts would not sit as an appellate authority to examine the recommendation of the selection committee. However, in the instant case, the petitioner was at number 3 in the merit list and had secured 75 marks out of 100 including 50 out of 60 marks in the trade test which is of vital importance as the selection was for the post of Driver. No reasons had been assigned as to why the petitioner was not recommended for selection although three posts had been advertised and the petitioner was at number 3 in the merit list. He was later employed on contractual basis by the respondents in 2014 and he is currently working with them. There does not seem to be anything adverse against his work and conduct.

Consequently the petition is allowed. The appointment of the petitioner would be treated as on regular basis w.e.f. the date the other two selected candidates had been appointed in pursuance to advertisement issued in 2013. He would be entitled to the notional benefits. Accordingly, he would be paid the salary in the regular pay scale henceforth.
