With reference to your application for the post of Professor (UR) in the Department of Computer Science & Information Technology in response to the Advt. No. CUH/03/R/T/2021 dated 08-09-2021 and subsequent interview held on 11-10-2022 for the above mentioned post, this is to inform you that the Competent Authority of the University has approved the recommendation of the Selection Committee for your appointment to the post of Professor (UR) in the Department of Computer Science & Information Technology. Accordingly, you are hereby offered the post of Professor (UR) in the Department of Computer Science & Information Technology in the Pay Level -14, Cell - 01, Rs. 1,44,200/- plus usual allowances as per the University Rules, w.e.f. the date of your joining. The appointment is however, subject to the following terms and conditions:-

- 1. You will be on probation for a period of one year from the date of your joining, which may be extended for another one year by the competent authority.
- 2. This appointment is subject to production of a certificate of your medical fitness from any Government Hospital/University Health Centre/Government Funded Medical College at the time of joining.
- 3. You will be governed by the New Pension Scheme, as notified by the Government of India, Ministry of Finance, as amended from time to time.
- 4. Your service will be governed by Act, Statutes, Ordinances, Rules and Regulations, Conduct Rules, administrative decisions and orders of the University which are in force at present and as may be amended/ modified from time to time. It will be obligatory on your part to acquaint yourself with various provisions of the University Act, Statutes, Ordinances, Regulations and rules and their amendments from time to time.
- 5. No travelling or any other allowance will be paid for joining the post.
- 6. Your seniority will be fixed by the University in accordance with the University Rules.
- 7. You will be entitled to other concessions/ facilities/ allowances/ leave as admissible to the teachers of the University under the University Rules.
- 8. Your pay will be fixed in accordance with the University rules.

- 9. You shall have to produce the following certificates/ documents in original and also one set of self attested copies thereof, for verification at the time of your joining:-

If any declaration given by you in the application form or any information furnished by you is proved to be false or you are found to have willfully suppressed any material information, you will be liable to be removed from service and also to face such other action as the University may deem necessary.



Respected Sir,

I joined as Professor in Computer Science and Information Technology, Central University of Harvana, Mahendergarh on 16<sup>th</sup> Dec, 2022. Due to the job of my wife and the study of the children, I shifted to Mahendergarh alone. As a result of relocating to a new area, I experienced several health problems, primarily chest pain. It created a lot of stress on me. Because of this stress, I started feeling deep anxiety and depression. My family and I got very worried. I started feeling that in these circumstances I will not be able to give my 100% to the University. I resigned from the post of Professor on January 18, 2023 and joined the Thapar Institute of Engineering and Technology, Patiala. With the help of medical support and meditation, my health has significantly improved. Now I believe that I could have handled the situation differently. You also advised me to take 1-2 months leave to get recovered but I was under so much stress that I wasn't able to understand. Now, I regret it very deeply. I feel that resigning from CUH was a grave mistake, as it is growing speedily and has a bright future under your leadership. I had the pleasure of meeting you three times during my stay at CUH. Subject:- Legal Opinion in respect of resignation of Dr. Singara Singh

The undersigned is in receipt of documents from your good self for tendering legal opinion in respect of resignation of Dr. Singara Singh. A careful perusal of the documents would revel that Dr. Singara Singh has joined as Professor in Computer Science and Information Technology with the university on 16.12.2022. However, owing to his health issues he resigned from service vide his resignation letter dated 18.01.2023, which was accepted by the Vice Chancellor on 18.01.2023 itself. It is also pertinent to note here that on his request Dr. Singara Singh was ordered to be relieved on 18.01.2023 by the University.

However, vide another letter dated 28.02.2023 Dr. Singara Singh has requested for Cancellation of his resignation and for rejoining of his duties as Professor in the University mentioning therein that the resignation was tendered by him by mistake as he was under stress.

The undersigned has carefully gone through the provisions/regulations governing the services of the teaching staff of the University apart from available record supplied by the University. The record transpires that the resignation of the Dr. Singara Singh was accepted by the Vice Chancellor by exercising its power 11(3) of The Central Universities Act, 2009 and he has further reported the same to the Executive Council which has taken note of the same in its 52<sup>nd</sup> meeting held on 20.02.2023.

Once, the resignation of Dr. Singara Singh has been noted by the Executive Council then it is the prerogative of the Executive Council either to accept and confirm such resignation or to accede to the request of the employee/teacher for its withdrawal.

In view of the above, it is for the Executive Council either to accept the resignation by Dr. Singara Singh or to accept his request for withdrawal of the same by him.
