Memorandum of Understanding
Between
Delhi Metro Rail Corporation Ltd. (DMRC)

and

Central University of Haryana, Mahendergarh

This Memorandum of Understanding (hereinafter referred to as MoU) is entered into on 06th day of June 2025, by and between:

Delhi Metro Rail Corporation Ltd., a company incorporated under the Companies Act, 1956, having its registered office at Metro Bhawan, Fire Brigade Lane, Barakhamba Road, New Delhi-110001 (hereinafter referred to as "**DMRC**"), which expression shall, unless it is excluded by or repugnant to the context, include its successors and permitted assigns, on the **First Part**.

And

Central University of Haryana, Mahendergarh, a Central University created through Central Universities Act, 2009, operating under the Ministry of Education (Govt. of India), mandated to cover the entire courses (hereinafter referred to as "**CUH**"), with headquarters at Mahendergarh, which expression shall, unless it is excluded by or repugnant to the context, include its successors and permitted assigns, on the **Second Part**.

DMRC and CUH are, hereinafter, collectively referred to as the "Parties" and individually as a "Party".

Both parties acknowledge the importance of fostering innovation and entrepreneurship to drive sustainable solutions, technological advancements, progress of the ecosystem, and promote economic growth. DMRC and CUH, in terms of this MoU have agreed to join hands to organise studies and research in the area of Transport and logistics, more particularly related to Metro Rail Technology. Both the parties decide to collaborate to leverage strengths of each other and assist to explore the possibilities to improve the brand with the intent to achieve a win-win solution.

DMRC and CUH desire to have a long-term association for academic collaboration for various objectives mentioned in this MoU. This MoU shall be identified as the parent document of any further agreement executed between the parties for any joint activity.

1. OBJECTIVE

The Parties hereby enter into this MoU with the following objectives:

- i. To promote research, education and training activities in respective institutions through collaborative efforts.
- ii. To deepen the understanding of the scientific, technological and management issues relevant to the respective institutions.
- iii. To establish a platform for seamless exchange of knowledge, ideas and expertise.
- iv. To combine strengths to foster innovative solutions across diverse disciplines.
- v. To enhance capacity building through participative learning.

2. PURPOSE & AREAS OF COLLABORATION

To achieve the above-stated objectives, the Parties shall engage in the following collaborative endeavors:

- i. Jointly conduct training courses/programs, under graduate programs, post graduate programs, doctoral programs, executive education, skill development, train the trainers, curriculum development, consulting, Continuing Education Programs, capacity building and Technology Enabled Education Programs.
- ii. Explore possibility of conducting Executive Development Programs (EDPs) for working professionals, both short term as well as long term.
- iii. Carry out and supervise joint research activities in order to deepen the analysis and understanding of science, technology, transportation and management areas of the respective institutions.
- iv. Organize joint events, such as workshops, conferences, symposiums, etc. related to various MRTS (Mass Rapid Transit Systems) domains.
- v. Collaborate towards joint submission for international projects and sponsored research opportunities.
- vi. Promote institutional exchanges by inviting faculty, students, and administrative staff of the partner institutions to participate in a variety of research activities and professional development opportunities.

- vii. Enhancing skills of students/aspirants through internship and learning trips.
- viii. Organize elective/regular courses for students of CUH on mutually agreed terms including curriculum development and conduct of training.
- ix. Organize short term training programs for employees of DMRC (and affiliates) on mutually agreed terms including curriculum development and conduct of training.
- x. Joint certificate Programs in the area of Metro Rail Technology and Management
- xi. Any other activity as mutually agreed by the DMRC and CUH

3. TRAINING, INTERNSHIP, COURSE MATERIAL, ACCOMODATION AND CHARGES

3.1 Training

On behalf of DMRC, DMRC Academy shall handle all activities pertaining to training like planning, execution and co-ordination.

CUH shall provide a list of students nominated to undergo training at DMRC Academy, one (01) month in advance. The minimum batch size for any training program shall be 15 or as mutually agreed between the two parties. The curriculum and duration of the training program shall be mutually agreed upon. Hostel facility may be availed by trainees during training (if required) on paid basis. However, provision of hostel facility will be subject to availability at that time.

DMRC Academy shall provide a list of topics for short term training programs for DMRC employees/officials to CUH. CUH, subject to feasibility will arrange the said training. Hostel facilities of CUH if available, may be made available to DMRC trainees on paid basis.

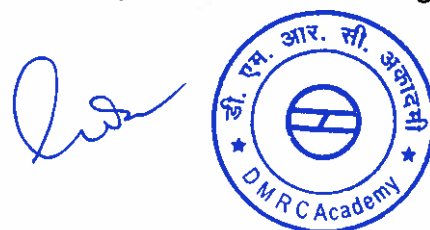
Both parties shall designate a liaison office for this MoU and for any subordinate agreements under this MoU. The management of this MoU will be carried out by a Coordinating Committee, composed of representatives from each party involved, which will provide guidance for all aspects of engagement.

3.2 Course Material

The students undergoing training at DMRC Academy shall be provided with training material in Soft Copy.

3.3 Training and Hostel Charges

The charges for training and hostel facilities during any training program conducted, whether at DMRC Academy or CUH, shall be mutually agreed upon a priori in writing.

3.4 Faculty Exchange

In consideration of faculty exchange, the inviting institute agrees to bear all expenses including travel, boarding, lodging, honorarium etc. for the visiting faculty.

3.5 Internship

Internship to CUH students shall be facilitated within the larger framework of organizational policies of both parties. The duration and structure of the internship program shall be mutually decided. The students shall be required to submit a Project Report on completion of internship. Internship shall be conducted by DMRC free of cost and no stipend shall be paid to the trainees for the internship. Hostel facility may be availed by students during internship (if required) on paid basis as agreed. However, provision of hostel facility will be subject to availability at that time.

3.6 Placement

It is expressly acknowledged that DMRC does not provide any guarantee of placement after completion of internship or any other training at DMRC Academy under this MOU.

4. GENERAL CONDITIONS

4.1 Validity

This document is a statement of intent to foster genuine and mutually beneficial co-operation and is not legally binding upon both the parties. Specific projects under this MoU will require a separate written agreement which will set forth the project scope of work, detailed methodology, roles and responsibilities, financial arrangements, milestones, deliverables, Intellectual property rights, confidentiality, duration of the project and other legal and administrative terms and conditions.

This MoU will remain in effect for a period of five (5) years unless terminated earlier by either party. The MoU may be terminated: (a) on either party giving the other party six months' prior written notice (b) on written notice by any of the parties if the other party has committed a breach of this MoU.

4.2 Extension, Amendment, Addendum and Renewal

The Parties may extend, amend, add an addendum or renew this MoU by mutual agreement through a written document signed by their authorized representatives.

4.3 Force Majeure

4.3.1 If either party is temporarily unable by reason of force majeure to meet any of its obligations under this MoU and if such party gives to the other party, written notice of event within fourteen (14) days after its occurrence, such obligations of the party which he is unable to perform by reason of event shall be suspended for as long as the event continues.

4.3.2 Neither party shall be liable to the other party for loss or damage sustained by such other party arising from any event referred to in this clause or the delay arising from such event.

4.3.3 The term "Force Majeure", as employed herein shall mean act of God, strikes, lock downs, war, civil riots, fire directly affecting the performance of the MoU, floods, change in law and regulations not within the control of either party and which by the exercise of due diligence neither party is able to overcome.

4.4 Limitation of Liability

Neither Party shall be liable to the other for any incidental, punitive, indirect, special or consequential damages or for loss of use or data or production or lost profits, savings or revenues of any kind arising under or in connection with this MOU, under any theory of liability (whether in contract, tort or otherwise). However, reasonable sufficient safeguards shall be taken to protect the interest of parties.

4.5 Dispute Resolution

Any difference or disputes between the parties concerning the interpretation and/or implementation and/or application of any of the provision of this MoU shall be settled amicably through mutual consultation and/or negotiation between the parties, without recourse to any third party or cost.

4.6 Intellectual Property

This MoU seeks the sharing and spread of the Intellectual Properties generated through activities under this MoU on mutually agreeable terms and conditions and subject to the current Intellectual Property Right (IPR) policies of each party. Each party shall adhere to the Intellectual Property laws of India. The parties shall meet through designated coordinators and seek an equitable and fair understanding as to the ownership and other Intellectual Property interests that may arise.

4.7 Confidentiality and Data Sharing

Both parties shall, during the tenure of the Agreement and at any time thereafter, maintain in the strictest confidence all information relating to the work. Neither party shall, unless so authorized in writing by the other party, divulge or grant access to any information about the work or its results. Furthermore, the parties shall not utilize any information acquired during the execution of this Agreement for any purpose without the explicit consent of the other party.

4.8 Waivers

It is fully understood and agreed that none of the terms and conditions of this AGREEMENT shall be deemed waived by either party unless such waiver is executed in writing by the duly authorized agents or representatives of both the parties, the failure of either party to execute any right shall not act as a waiver of such right by such party.

4.9 Notices

Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing, in English/Hindi and delivered personally or sent by registered or certified post via courier or email (which shall be acknowledged by the other Party) to the Parties at the addresses stated below:









This MoU shall come into force as soon as it is signed for all purposes and intent and shall, unless earlier terminated by mutual consent, remain in full force.
