I am directed to refer to your letter no. CUH/2025/Reg.Off./1762 dated 11.06.2025 regarding participation in the Free Coaching Scheme for Students with Disabilities (SwDs), and to convey appreciation for your willingness to implement the scheme at the university campus. The Department acknowledges receipt of the signed Memorandum of Understanding (MoU) and the accompanying financial proposal amounting to ₹2,14,50,000/- for a period of five years.

2. After due examination, it is informed that the Free Coaching Scheme does not provide for funding towards infrastructure development or capital expenditure. The scheme is specifically intended to support SwDs by covering coaching fees and providing stipends and allowances to the students, as detailed below:

The submitted MoU has been counter signed, and you are requested to complete the onboarding process on the PM Daksh Free Coaching Portal (https://pmdaksh.depwd.gov.in/FreeCoaching/login) and initiate exclusive free coaching batches for Persons with Disabilities (PwDs), including those with visual, hearing, and speech impairments, while ensuring the provision of special educators as per their needs.

Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India having its office at 5th Floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi 110003 (hereinafter referred to as the "First Party" or "DEPwD" or "PM DAKSH-DEPwD" or "Department" which expression shall unless excluded by or repugnant to the context, be deemed to include its successors-in interest permitted administrators, assignees and nominees of the First Party, represented by the Deputy Director General, Department of Empowerment of Persons with Disabilities (Divyangjan), New Delhi.

Referred to as Second Party (The above entities are hereinafter collectively referred as "Parties" and individually as "Party").

NOW THEREFORE, in consideration of mutual covenants and understandings herein contained, the Parties hereto agree to this MoU:

#### 1) PREAMBLE

## (i) Department of Empowerment of Persons with Disabilities (DEPwD)

Department of Empowerment of Persons with Disabilities (DEPwD), Government of India, acts as a nodal agency for matters pertaining to disability and persons with disabilities including effecting closer coordination among different stakeholders: related Central Ministries, State/UT Governments, NGOs etc. in matters pertaining to disability.

The major objectives of the Department are:

(i) Physical rehabilitation, which includes early detection and intervention, counselling & medical rehabilitation and assistance in procuring appropriate aids and appliances for reducing the effect of disabilities;

(ii) Educational rehabilitation including vocational education;

(iii) Economic rehabilitation and social empowerment;

(iv) Developing rehabilitation professionals/personnel;

(v) Improving internal efficiency /responsiveness/service delivery; and

(vi) Advocating empowerment of persons with disabilities through awareness generation among different sections of the society.

Central University of Haryana is one of the fifteen new Central Universities established by Ministry of Human Resource Development, Government of India (GoI) in XI Five Year Plan (2007-2012) under the Central University Act-2009 of the Parliament.

The University has been accredited with 'A' Grade in the second cycle of NAAC assessment and accreditation conducted in August 2023. The University is fully funded by the University Grants Commission (UGC). Permanent Campus of the University is situated in 484 acres of land at Jant-Pali Villages, Mahendergarh district of Haryana from where CUH is running its academic operations. Presently the University offers 83 academic programmes (UG/PG/Research).

- V. The university is dedicated to creating an inclusive campus environment that supports students from diverse backgrounds and contributes to sustainable societal progress through education, outreach, and community engagement.

#### 2) PURPOSE/ DELIVERABLES

(i) (Central University of Haryana, jant-Pali, Mahendragarh) is one of the various Implementing Agencies, will be responsible for implementation of Free Coaching (For recruitment examinations for Group A, B and C posts and entrance examinations for admission to various technical and professional courses) component of "Scheme of Scholarships for Students with Disabilities" of Department of Empowerment of Persons with Disabilities. The scheme will be implemented through the Empanelled Cental/State Universities/Institute (Central University of Haryana, Jant-Pali, Mahendragrah).

(ii) (Central University of Haryana, Jant-Pali, Mahendragrah) will be providing coaching facilities to students with benchmark disabilities (having a minimum of 40% disability) to enable them to appear in competitive examinations for government jobs and seek admission to various professional and technical courses. The courses for coaching and number of slots & its distribution will be as per scheme guidelines issued by the DEPwD.

(iii) Mode of disbursement of stipend and fee will be as per scheme guidelines issued by the DEPwD.

(iv) (Central University of Haryana, Jant-Pali, Mahendragrah) will be responsible for engagement of required staff having specialization in respective field with adequate knowledge.

#### 3) General Condition

(i) The appraisal of the implementing agencies should be performance-based. Review of performance of Implementing Agency at the end of six months from commencement of the 1st batch of Free Coaching for PwD. After that every year performance of Implementing Agency (IA) will be reviewed by the Department.

(ii) **Provision for Pre-Mature Exit:** Either party may terminate this MoU with completing ongoing tasks and one month written notice to the other party.

(iii) IA will not allow outsourcing for coaching.

(iv) IA will ensure that the coaching for the indicated course will be provided in the own campus.

(v) IA shall ensure recording of Aadhaar based biometric attendance of the students and shall share the same with the Department as required.

(vi) The Implementing Agency shall conduct the coaching for the indicated course as per the MoU signed between them and the Department. The Implementing Agency is responsible for determining the courses offered and the size of each batch.

(vii) Responsibility of Implementing Agency about eligibility of students: The Implementing Agency shall check the credentials relating to educational, UDID card/disability certificate, income etc. of the students coached by them from the originals of such documents and certify that they are satisfied that these students are genuine and eligible students. After short listing the candidates, the implementing Agency shall forward a list of all the shortlisted candidates to this Department. If at any stage it is found out that any or all of such students were not eligible on account of education, category of disability, annual family income etc., the Implementing Agency coaching such student shall be solely responsible. No fee/stipend shall be released in respect of such students and further if any payment has already released to such students before coming into knowledge of their ineligibility for availing benefits under the scheme, the amount shall be recovered from the students and concerned institute with penalty, if any, decided by the Department.

(viii) Coaching fee/Tuition fee shall be released on advance basis through a Central Nodal Agency (CNA). CNA would release payment to the Implementing Agency on monthly/Quarterly basis.

## 4. ELIGIBILITY CRITERIA AND OTHER CONDITIONS FOR STUDENTS WITH DISABILITIES

All the below mentioned eligibility criteria from point (i to xi) is as per para 14.7 (page no. 5 to 7) of revised guidelines of Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment, Government of India (No. Z-11017/85/2023-SCH, dated-26-07-2024) for the scheme of Free Coaching for Students with Disabilities (SwDs)

(i) The Scheme is only for Indian Nationals

(ii) The scheme is only for Indian nationals. The scheme is open to students with benchmark disability i.e. 40% or more disability as defined in 'Rights of Persons with Disabilities Act, 2016 and having a valid certificate of disability issued by the competent authority as prescribed under Rules.

(iii) Aadhar Number or Aadhar Enrolment number would be mandatory and aadhaar based bio-metric authentication of the candidates may also be done.

(iv) Unique Disability ID (UDID) number with disability certificate is mandatory.

(v) Not more than two children with disabilities of the same parents will be entitled to receive benefits of the scheme. In case the second child is a twin, the benefits under the schemes will be admissible to the twin.

(vi) Benefits under the Scheme can be availed by a particular student not more than once, irrespective of the number of chances he/she may be entitled to take in a particular competitive examination and irrespective of the number of stages in the exam.

(vii) Only students with benchmark disability, having total family income from all sources of Rs. 8.00 lakh or less per annum will be eligible for benefits under the Scheme.

(viii) Income Certificate: Income declaration of self-employed parents/guardian should be in the form of a certificate issued by a Revenue Officer not below the rank of Tehsildar/ Naib Tehsildar. Employed parents/guardians are required to obtain income certificate from their employer and submit consolidated obtain income certificate from Revenue Officer including any other additional source of income.

(ix) For the competitive exams for which the qualifying exam is class XII, benefits under the scheme will be available to a candidate only if the candidate has passed class XII or is studying in class XII as on date of receiving the benefits under the scheme. Student will be required to declare the marks obtained by him/her in class X in the application form which shall be reckoned for the purpose of evaluating his/her eligibility. Students having less than 50% marks in their class X exam, shall not be considered under the scheme.

(x) Further, in case of competitive exams for which the qualifying exam is at bachelor level, only students/candidates having completed the bachelor level course or studying in the final year of the bachelor degree course at the time of receiving the benefits under the scheme shall be eligible. Student will be required to declare the marks obtained by him/her in higher secondary examination which shall be reckoned for the purpose of evaluating his/her eligibility. Students having less than 50% marks in their class XII exam, shall not be considered under the scheme.

(xi) The candidate shall be precluded from availing benefits under any other coaching scheme of the Centre or State government and will be required to provide a declaration to this effect.

#### 5) PROCESS OF APPLICATION AND SELECTION OF THE CANDIDATES

(i) Application for free coaching will be invited by respective Implementing Agencies in OFFLINE or ONLINE mode and candidates for free coaching will be selected after assessing the eligibility and Suitability and within the approved slots.

(ii) There will be 30% reservation for the female students. In case adequate number of female candidates are not available or not found eligible as per the terms and conditions of the scheme, the unutilized slots will be utilized by selecting suitable male candidates.

#### 6) PRESCRIBED COURSES FEE AND STIPEND

## ii. Stipend and Other Allowances to be paid to the candidates: Stipend/ Maintenance allowance:

Rs. 4000/- per month Disability Allowances

Rs.2000/- per month

Book Allowance: Rs. 5000 per course (One Time)

Note: stipend/maintenance allowance/ Disability Allowance shall be paid for the actual months of coaching or for the maximum prescribed duration, whichever is less, even if the concerned Implementing agency has imparted coaching for a period beyond the maximum duration prescribed. The funding pattern should be implemented through the Direct Benefit Transfer (DBT) mode through PFMS.

## 7) PERFORMANCE AND MONITORING:

(i) Concerned Implementing agency will review of the performance of the selected candidates availing the benefits of the scheme based on the information obtained from the candidates about their success or otherwise in the competitive exams.

(ii) In order to ensure proper accountability, physical verification of at least 10% of the institutes/Students chosen randomly through an algorithm shall be done by the Department.
