# MEMORANDUM OF UNDERSTANDING

BETWEEN

S. M. REHABILITATION & RESEARCH CENTRE (SMRRC)

AND

CENTRAL UNIVERSITY OF HARYANA,  
JANT-PALI, MAHENDRAGARH, HARYANA

This memorandum of Understanding (MOU) is drawn up and agreed upon to establish the initial framework for cooperation between S. M. Rehabilitation & Research Centre and Central University of Haryana, Jant-pali, Mahendergarh, Haryana.



This MoU is signed on 30/06/2025, 2025 between the following parties:

S. M. Rehabilitation and Research Centre, located at Site 1, Part 2, Sector 1, JUDA, Narnaul, Haryana 123001, represented by the Principal: The Centre is established under the Santosh Memorial Education Welfare Society, a registered society under the Societies Registration Act of 1860 since 2002. The Society is also registered under the Rights of Persons with Disabilities Act, 2016, the National Trust Act, as well as under Sections 80G and 12AA of the Income Tax Act. The Centre provides comprehensive services for children with and without disabilities, including Special Education, Rehabilitation, Awareness & Sensitization, Advocacy, Counselling, Parental Training, Community-Based Rehabilitation (CBR), Continuing Rehabilitation Education (CRE), In- service Training, Cross-Disability Training, and Skill Development & Training for the empowerment of Persons with Disabilities (PwDs), among others.

(Hereinafter referred to as "the first party" or "SMRRC")

The university (hereinafter referred to as CUH) has been accredited with an "A" grade in the first cycle and second cycle of NAAC assessment and accreditation conducted in March 2023. The university is fully funded by the UGC. Permanent campus of the university is situated at Jant-Pali village, Mahendergarh district of Haryana from where CUH is running its academic operations. Presently, the university offers academic programs at UG, PG and Research level.

The SMRRC and CUH are individually referred to as "Party" and collectively as "Parties."

#### AIMS & OBJECTIVES:

- A. This MoU establishes a partnership between Haryana Central University, Pali Jant and S.M. Rehabilitation and Research Centre, Narnaul, focused on the development and rehabilitation of Children with Special Needs (CWSN). The collaboration aims to enhance the rehabilitation, education, and skill development of individuals with disabilities.
- C. Key initiatives include awareness programs to promote inclusivity, advocacy, counselling, and training for families and caregivers, as well as engaging in research and academic activities on disability issues.
- D. The partnership also seeks to foster knowledge exchange, support professional development, and explore funding opportunities for projects that benefit individuals with disabilities.

#### TERMS & REFERENCE OF MOU:

- 1- SMRRC and CUH will collaborate to promote awareness about Children with Special Needs (CWSN) and disabilities among students and teacher trainees. They will jointly raise awareness about essential services such as:
- UDID cards
  - Disability Certificates
  - Assistive Devices

d. Transportation Concessions

2- SMRRC and CUH will work together on Healthcare & Rehabilitation Services and will undertake:

- a. Initiatives for screening, diagnosis, early intervention, and rehabilitation for Persons with Disabilities (PwDs).
- b. Faculty and students of both parties will be engaged in related research, fieldwork, and training programs.

3- Trainees from CUH will have the opportunity to visit SMRRC for internships and training programs focused on disability rehabilitation, with prior approval. Both institutions will jointly develop and implement capacity-building programs for teachers, healthcare professionals, caregivers, and community workers.

4- SMRRC and CUH will advocate for disability rights and collaborate with government agencies, NGOs, and organisations to implement rehabilitation projects. They will jointly raise awareness about UDID card registration and assist PwDs in accessing government resources and schemes.

5- SMRRC and CUH will jointly organise health camps, vaccination programs, and other welfare activities for PwDs and the general public. Both institutions will contribute to public health research by involving faculty and students.

6- Both institutions will share resources, including personnel and infrastructure, to support joint initiatives and programs. No fees will be charged for training or sensitisation programs. All activities will be mutually agreed upon.

7- Both institutions will share resources and collaborate on research activities, seminars, webinars, conferences and workshops to promote disability awareness and academic growth.

8- The scope of responsibilities set forth by the parties under this MoU will be carried out by the parties on terms and conditions as mutually agreed between them from time to time.

- 9- For smooth working and convenience, Dr. RN Yadav, Principal, S. M. Rehabilitation & Research Centre and Dr. Payal Chandel from the Department of Psychology, Central University of Haryana, shall be the point of contact for the respective universities.

#### **CONFIDENTIALITY:**

Each party will: (a) keep confidential all information disclosed to it by the other party; (b) use such information solely for non-commercial, in-house evaluation; and (c) make such information available only to those of its employees who need to know such information in connection with such evaluation and them, only to the extent of such need to know.

#### **DURATION, TERMINATION & REVIEW OF MOU:**

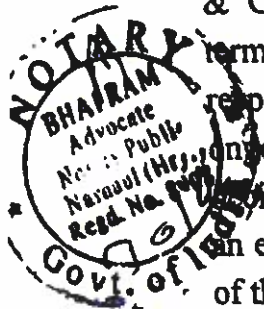
Arrangement under this MoU will be operative for a period of three (5) years commencing from the date of signing this MOU between SMRRC & CUH. Further, a continuance of this MoU would be subject to joint review by SMRRC & CUH to be undertaken prior to the expiry of this MoU. In the event of termination or non-renewal of the MoU on its expiry, it would be the responsibility of the parties to complete and provide their services under the ongoing project contemplated under the terms of this MoU. The parties will abide in good faith within thirty (30) days upon concern of occurrence of such an event, the time period, along with all other support to manage the completion of the ongoing project.

Further, any term constituting this MoU may be reviewed, modified or amended in writing at any time by mutual consent of both the authorities undersigning and will be construed as part of this MoU.

In addition, the authorised representatives of the parties will consult each other from time to time with regard to the implementation of this MoU.

#### **SETTLEMENT OF DISPUTE:**

- a) The MoU stands terminated by either party at any time with prior written notice of thirty (30) days without citing any reason thereof. b) This agreement shall be governed by and following the laws of India & conflicts,
