

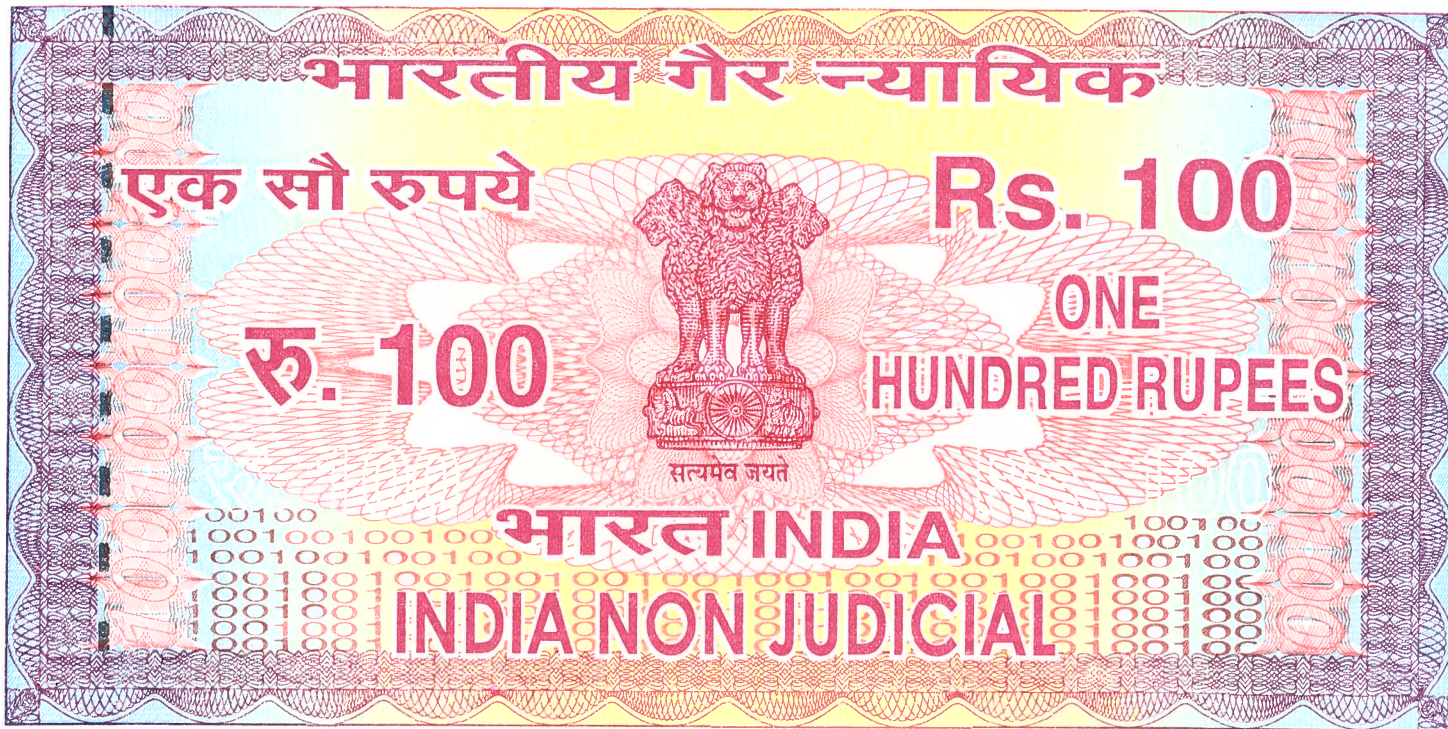

5. **CONFIDENTIAL INFORMATION**

The parties hereto agree not to disclose any confidential information of the parties to the other except where the disclosure is necessitated by any law for the time being in force.

6. **AMENDMENTS AND MODIFICATIONS**

Any amendment or modification to this Agreement shall be in writing signed by both the parties hereto.

7. **TENURE**

- a) This agreement shall remain in force for a period of Five years (60 Months) from the date of signing of this MOU. It may be further extended for another period as agreed both mutually upon expiration.
- b) In the event of the termination of this Agreement, the rights and obligations herein contained shall continue to operate on both parties till the conclusion in all respects



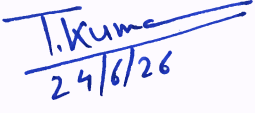
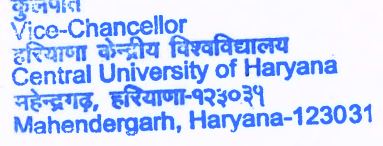
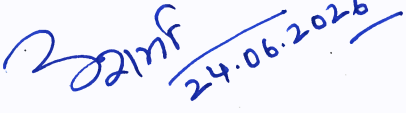
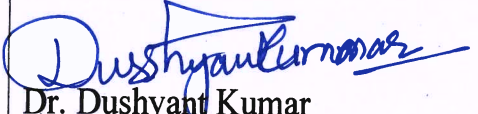
