**Tenure:** All members of the Academic Council, other than Vice-Chancellor, Pro-Vice-Chancellor, Dean of Students Welfare, Proctor and Librarian shall hold office for a term of three years provided that the tenure of student members shall be one academic year.

**Quorum:** "Half of the total members of the Academic Council excluding the Vice-Chancellor shall make the quorum for the meeting of the Academic Council".
