NOTICE INVITING QUOTATION NO. 26/2025

Name of Work: Providing and fixing of Acrylic LED based sign board with ACP sheet Base over Administrative Building at CUH.

Sealed item rate quotations are invited on behalf of Central University of Haryana, Mahendergarh for the above mentioned work from the manufacturer of LED based Sign Board. The quotation should reach the office of the Executive Engineer, Room No.-217. Administrative Building, CUH on or before 03/02/2025 upto 02:00 PM. The quotation shall be opened on the same day i.e. 03/02/2025 at 03:00 PM. The bidders or their representative may attend the said meeting on 03/02/2025.

The terms & conditions for the same are given below:

- 1. The BOQ is attached as Annexure-'I'.
- 2. The work will be carried out as per the satisfaction of the engineer in charge.
- 3. The agency/firm must deposit EMD of Rs. 6,500/- (Rupees Six thousand five hundred only) in the form of NEFT/RTGS in favour of Central University of Haryana's Account No. 7824000100000392 IFSC Code: PUNB0782400 (Punjab National Bank, Jant-Pali, Mahendergarh).
- 4. The agency must submit the details of EMD submitted to CUH i.e. UTR details etc. along with bank account details of the agency/firm for the purpose of release of EMD of unsuccessful bidders.
- 5. GST registration certificate of the agency is required to be enclosed along with quotation.
- 6. Validity of the quotations will be 60 days from the date of opening.
- 7. The rate includes all taxes like GST, and other taxes and carriage of the material etc., nothing extra shall be paid.
- 8. Time of completion of work will be 30 days.
- 9. No advance payment will be made.
- 10. Conditional quotations will not be considered.
- 11. The agency should inspect the site before quoting the rate.
- 12. The quantity of items in BOQ is tentative which may change depending upon site conditions.
- 13. The agency should provide proper safety tools to its workers. The CUH will not be responsible for any accident.
- 14. Time is the main essence of the contract. Hence, an appropriate penalty upto 10% maximum can be imposed on the agency for delayed completion of work.
- 15. No labour below the age of 18 years be employed on site.
- 16. All T&P required will be arranged by the contractor.
- 17. Security deposit @5% and necessary recoveries i.e. GST, Labour Cess and Income Tax etc. will be recovered from the bills of the contractor.
- 18. The agency shall submit sample for approval of the competent authority before start of work.
