NOTICE INVITING QUOTATION NO. 27/2025

Name of Work: Providing and fixing of 11 KV, 630 A, STC 21 KA/3 SEC, Safe Ring XT, CCV Manual Outdoor Ring Main Unit (RMU) Panel near New Girls Hostel at CUH.

Sealed item rate quotations are invited on behalf of Central University of Haryana, Mahendergarh from the manufacturer or their authorized dealers, who have satisfactory completed at least three works of similar nature. The quotation should reach the office of the Executive Engineer, Room No.-217, Administrative Building, CUH on or before 05/03/2025 upto 01:00 PM. The quotation shall be opened on the same day i.e. 05/03/2025 at 03:00 PM. The bidders or their representative may attend the said meeting on 05/03/2025.

The terms & conditions for the same are given below:

- 1. The BOQ is attached as Annexure-'I'.
- 2. The work will be carried out as per the satisfaction of the engineer in charge.
- 3. The agency/firm must deposit EMD of Rs. 9,500/- (Rupees Nine Thousand Five hundred only) in the form of NEFT/RTGS in favour of Central University of Haryana's Account No. 7824000100000392 IFSC Code: PUNB0782400 (Punjab National Bank, Jant-Pali, Mahendergarh).
- 4. The agency must submit the details of EMD submitted to CUH i.e. UTR details etc. along with bank account details of the agency/firm for the purpose of release of EMD of unsuccessful bidders.
- 5. GST registration certificate of the agency is required to be enclosed along with quotation.
- 6. Certificate of experience of satisfactory completed at least three works of similar nature.
- 7. Validity of the quotations will be 30 days from the date of opening.
- 8. The rate includes all taxes like GST, and other taxes and carriage of the material etc.,
- 9. Time of completion of work will be 15 days.
- 10. No advance payment will be made.
- 11. Conditional quotations will not be considered.
- 12. The agency should inspect the site before quoting the rate.
- 13. The agency should provide proper safety tools to its workers. The CUH will not be responsible for any accident.
- 14. Time is the main essence of the contract. Hence, an appropriate penalty upto 10% maximum can be imposed on the agency for delayed completion of work.
- 15. No labor below the age of 18 years be employed on site.
- 16. All T&P required will be arranged by the contractor.
- 17. Security deposit @5% and necessary recoveries i.e. GST, Labour Cess and Income Tax etc. will be recovered from the bills of the contractor.
