3.2 Project Cost: Rs. 200.00 Crores (approx.)

Broad Scope of PMC Services 3.3

The CUH campus at Village Jant-Pali, Distt. Mahendergarh, Haryana- 123029 is presently running its permanent campus on 484 acres of land. Infrastructure requirements and construction of the buildings as elaborated in EOI are proposed to be constructed for the balance FAR. The Master Plan is available and can be seen at the office of Executive Engineer-CUH. For the Master Planning of new construction, FAR as per bye-laws shall be covered. In the campus of CUH, the following buildings and infrastructure will be constructed in a phased manner:

i. School of Engineering & Technology Block at CUH

- ii. Central Instrumentation Centre at CUH
- iii. 16 Nos. of Lecture Halls, behind the existing Academic Block-1 at CUH
- iv. 02 Nos. Girls' Hostel Blocks for 630 Nos. students at CUH
- v. University Computer Centre Building
- vi. Multi-purpose hall at Central University of Haryana
 vii. Development of Sports ground (04 Volleyball courts, 02 Basketball courts and 04 Tennis courts) at CUH
- viii. Animal House for experimental facilities at CUH
- ix. Repair & recarpeting of bituminous road

The proposed campus will focus:

- i. On the lowering operational, maintenance and energy costs.
- ii. To reduce the operational cost and offset the rising cost of energy.
- iii. To provide the highest quality of indoor air and ensure optimal health and safety for the employee, that will lead to high levels of productivity.
- iv.Improve energy optimization & control.
- v. Develop a system that is to be user-friendly, economical to operate and allow up gradation and flexibility to handle numerous office re-organization without operational shutdowns.
- vi.To provide off-site monitoring capability for better building management.

To fulfill these objectives, it is proposed to engage a Project Management Consultant (PMC) to manage all the activities involved in the project like planning, designing, detailed engineering and execution through efficient planning, scheduling, controlling and monitoring. The scope of PMC services will include scrutiny of planning, design, drawings and estimates etc. prepared as well as managing execution of works as per extant rules/guidelines of Centre/State Government including appointing Contractors through a competitive bidding system following latest GFR. For the preparation of design and drawings for this project, an Architect will be appointed by PMC with the consent of CUH.

At any time before the submission of proposals, CUH may, for any reason, whether at its own initiative or in response to a clarification requested by an invited bidding firm, modify the documents by suitable amendments. The amendments shall be uploaded online and will be binding to all firms. CUH may, at its discretion, extend the deadline for the submission of proposals.

3.4 Local Conditions and Preliminary Costs

1. Each Bidder should fully acquaint himself of all local conditions, local bye laws and factors, details of plot of land which may have any effect on the execution of services covered under this document and specifications. It must be understood and agreed that all the factors have properly been investigated and considered by the Bidders before submitting the proposals. CUH will not entertain any claim or financial adjustment or modifications in time schedule

which arise due to inadequate appreciation by the Bidder at the time of submission of bid. The bidders are strongly advised to inspect the site and assess all site conditions including geotechnical conditions.

 All costs of preparing the proposals including site visits etc. shall be borne by the Bidders. No claim would be accepted at a later date arising out of inadequate assessment of site conditions/requirements.

3.5 Time schedule

Time for completion of project will be finalized after selection of PMC 36 months and additional 36 months for defect liability period. The basic consideration and the essence of the contract shall be adherence to the time schedule for performing the Project Management Consultancy services for developing the campus of CUH.

3.6 Pre-Qualification Criteria:

4. VISION AND REQUIREMENTS

4.1 Background

Mahendragarh was earlier known as 'Kanaud' because of its association with Kanaudia group of Brahmans. During the middle of the nineteenth century, it came to be known as Mahendragarh. Although the nomenclature of the district is not very old, the archaeological explorations conducted in the region have brought to light late- Harappan sites in the Rewari tehsil. However this type of evidence along with Painted Grey Ware (PGW), Northern Black Polished Ware and Early Historical Ware has been also gathered from the adjoining districts of Bhiwani and Gurgaon. So far not a single PGW site has come to light in the district, perhaps suggesting the north-eastward migrations of the Aryans from the banks of the Saraswati and the Drisadvati possibly happened due to the drying up of their courses. Most of the sites explored in Mahendregath belong to the late-medieval period. The district, it may further be pointed out, might have possibly remained outside the main stream of Aryan culture and hence has not been specifically mentioned in the traditional literature as an independent territorial unit. However, it has been suggested that some of the present streams of the district may be identified with those mentioned in early Vedic literature.

Mahendragarh is emerging as the new education hub of Haryana with several high standard schools, like Yaduvanshi Shiksha Niketan and colleges, including engineering colleges and a Central University having come up here. It is also having top class health facilities.

Mahendragarh district is one of the 22 districts of Haryana state in northern India. The district occupies an area of 1,899 km² and has a Population of 922,088.

Presently Central University of Haryana is one of the fifteen new Central Universities established by Ministry of Human Resource Development, Government of India (GOI) in XI Five Year Plan (2007-2012) under the Central University Act-2009 of the Parliament.

The University has been accredited with 'A' Grade in the NAAC assessment and accreditation conducted in 2023. The University is fully funded by the Ministry of Education, Govt. of India. Permanent Campus of the University is situated in 484 acres of land at Village Jant-Pali, Mahendergarh district of Haryana from where CUH is running its academic operations. Presently the University offers 83 Academic programmes (UG/PG/Research).

The CUH campus at Village Jant Pali, Distt Mahendergarh, Haryana -123029 is under development on 484 acres of land. Infrastructure requirements are already in place. Requirements of various building structures have been projected now. The expansion of the University in terms

of Academic Block, Sports Complex, Hostels, Multipurpose halls, Lecture halls, University Computer Centre, Central Instrumentation Centre etc has to be constructed.

4.2 **Vision and Mission**

VISION:

5. Bid Process & Evaluation

The bids from the Bidders are invited for providing Project Management Consultancy Services for planning and development of future Buildings and expansion of Central University at Village Jant-Pali, Mahendergarh, Haryana. The evaluation of bids shall enable the shortlisting of PMCs. The eligibility criteria for Consultants participating in the selection process are laid down in the subsequent section:

5.1 Eligibility Criterion

The bidder shall be shortlisted on the basis of their experience, organization structure and capability. All Bidders have to fulfill the following conditions of eligibility for shortlisting.

5.1.1 Experience of Similar Projects

The Bidder should have satisfactorily completed one similar project total value of Rs. 120 Cr. or two similar projects of value of Rs. 90 crores each or three similar projects of value of Rs. 60 crores each during the last 7 years ending previous day of last date of submission of tender. PMC should be having experience and knowledge in planning and execution of similar projects with state of the art facilities. PMC should also have expertise in contemporary building construction techniques, educational, Institutional, R&D Projects involving buildings and external development works. Further the PMC are expected to have experiences in developing green campuses with GRIHA norms/ Net Zero buildings.

The certificate should include the value of the project stating cost of overall project with details, year of completion and time over-run and penalty imposed.
- (iv) The experience certificate where penalty has been imposed on the work shall not be considered for the evaluation process.
- (v) The cost of the projects shall not include the cost of land, godowns and semi-permanent structures for the purpose of eligibility.
- (vi) Particulars of completed projects and performance of the Bidder duly authenticated/certified by an officer not below the rank of Executive Engineer or equivalent should be furnished separately for each project completed.

5.1.2 Minimum Overall Experience

The overall experience of the firm should not be less than 10 years on previous day of last date of submission of tender. This means that the firms should be in practice and providing PMC services in Civil and Electrical works for a minimum period of last 10 years.

5.1.3 PMC Services

All the bidding PSUs / State & Central Government should be duly authorized by the concerned Central/State Governments to provide PMC services in the country. Schedule-B and above, Central Public Sector Undertaking set up by the Central Govt. to carry out Civil or Electrical works as per GFR clause 133(3) can participate in the bid and the PSUs notified by the Ministry of Urban Development for such purpose can participate in the bid. Further, if the Bidder has been debarred/ restrained/ black listed by any Central Govt. / State Govt. agency/Autonomous body of the Central or State Govt./ PSU etc. in the past from providing consultancy services then he will not be eligible to participate in the bidding process for selection of Consultant.

5.1.4 Annual Turnover& Technical Manpower

The bidder's Gross average annual turnover in the last three years should not be less than Rs. 600.00 Crores (Rs Six Hundred Crores) ending up to 31.03.2023. Further the bidder should have minimum 100 regular engineers (with minimum B.Tech Qualification) in the discipline of Civil, Electrical and Mechanical Engineering on its regular rolls.

5.1.5 : Annual Profit of bidder:

The PMC/PSU should be in profit. The PMCs/PSUs shall not in loss during the last 03 financial years.

5.2 Settlement of Disputes

In the event of dispute in the process, the settlement will be done by Dispute Resolution Committee (DRC) appointed by Hon'ble Vice-Chancellor, CUH or through Civil Court at Mahendergarh jurisdiction.

5.3 Additional Information:

CUH reserves the right to:

- i. Postpone and/ or extend the date of receipt of or to withdraw the bidding notice without assigning any reason thereof, entirely at the discretion of the CUH. In such an event, consulting firms shall not be entitled to any compensation in any form whatsoever.
- ii. Reject or accept bids; and
- iii. Cancel the bidding process and reject all or any of the proposal and will not be bound to accept any proposal or to give any reasons for the decision in the consultation with the selection committee.
- iv. This document is non transferable.
- v. In case, the last date for submission & opening of tenders is declared as a public holiday, the next official working day shall be deemed as last date of submission and opening of proposals without any change in time indicated. No separate notice to this effect shall be issued.
